Dear Prospective Pitcher,

We would first of like to thank everyone who participated in making the 2007 Team World event a success. A total of 18 teams participated and at the end of the tournament Team Colorado came out on top for the 5th time.

2008 will be the 24th year of the tournament and the 19th time it will be held at the Edwards Ice Arena in Beloit, WI. The event will be held May 16th, 17th & 18th on 24 portable courts.

Over the three days each team will play all the opposing teams. After completion of the round robin a step-ladder playoff will decide the winner. Ladder placement will be based on the number of matches won in the preliminary rounds. Depending on the number of entries, there will be five to seven teams that will enter the playoffs on Sunday afternoon.

Each team should consist of 4 or 5 players. Each team is limited to two 30 foot pitchers. The top team from each state or province has priority in the event we have too many teams.

If you have never participated in a Team World tournament, 2008 will be a great year to start. If you have trouble gathering a team try contacting your state or province charter officers. They will hopefully help you contact potential teammates. If not you can also contact members of the committee and we will help you in any way we can.

The entry fee is \$200 per team, which could be sponsored by the state or province charter. A scorekeeping fee of \$1 per game, per player will be assessed when teams arrive to check in on Friday. More information will be provided after team entries are gathered.
